



Warranty Information

Your Olson Technology Inc. equipment is covered by a one year limited warranty. If it is necessary to return the unit(s) for repair, please observe the following procedures:

- 1) Telephone our customer service department at (800) 545-1022 and request a Return Merchandise Authorization (RMA) Number before the unit is sent in. We will not accept any returned material without prior authorization.
- 2) Any unit(s) authorized for return should be adequately boxed in either the original shipping box or with adequate packing material (3 to 4 inches) for UPS shipment.
- 3) Any unit that is returned and found to be in proper working order will be charged \$100.00 for handling and testing. If the problem is intermittent, please make a note to that effect and fully explain the circumstances under which the problem(s) occur.
- 4) Funds for Out of Warranty repair, and/or the fund due for units still under warranty but found by Olson Technology to be in proper working order, are due prior to return shipping.

WHO PROVIDES THE WARRANTY This warranty is provided by Olson Technology, Inc.

WHO IS PROTECTED This warranty is extended only to the original owner of this Olson Technology product and may not be transferred or assigned.

WHAT IS COVERED AND HOW LONG This warranty covers all defects in material or workmanship of our product for a period of one (1) year from date of original retail purchase. At its option, Olson Technology will repair or replace any defective part(s) or equipment which has not been damaged, as more fully explained under **"What Are The Exceptions."** Olson Technology requires prepaid return of defective products or parts to our factory or to an authorized service facility for inspection.

Replacement parts supplied under this warranty are warranted only for the remaining portion of the original warranty period.

Transportation charges, insurance fees, and labor costs for shipment, removal or reinstallation of our product are not covered by this warranty. Also, loss or damage in shipment is the sole responsibility of the freight carrier. Olson Technology shall in no event be liable for loss of use of our products or consequential damage, including, but not limited to damages to other parts or equipment of any installation of which this Olson Technology product is a part. A customer will be charged a minimum of \$100 for technician and hand line time if the unit is found to be in proper working order. If the problem is intermittent please attach a note fully explaining the trouble.

FOR YOUR INFORMATION Repair as provided under this warranty is the exclusive remedy of the buyer. Olson Technology shall not be liable for any incidental or consequential damages for breach of any express or implied warranty on this product. Except to the extent prohibited by applicable law, any implied warranty of merchantability or fitness for a particular purpose on this product is limited in duration to the duration of this warranty.
